(SANTUC FIRE DISTRICT OF UNION COUNTY)

ORDERING A REFERENDUM IN THE SANTUC FIRE DISTRICT IN UNION COUNTY, SOUTH CAROLINA, TO SUBMIT THE QUESTION OF WHETHER THE FIRE DISTRICT SHALL BE AUTHORIZED TO ISSUE NOT EXCEEDING \$500,000 GENERAL OBLIGATION BONDS; AUTHORIZING AND PENDING THE FAVORABLE RESULTS OF THE REFERENDUM, APPROVE THE ISSUANCE BY THE BOARD OF FIRE CONTROL OF THE SANTUC FIRE DISTRICT OF NOT EXCEEDING \$500,000 GENERAL OBLIGATION BONDS; PROVIDING FOR THE FORM OF BALLOT TO BE USED; PROVIDING FOR THE NOTICE OF REFERENDUM; AND PROVIDING FOR ALL OTHER MATTERS RELATING THERETO.

BE IT ORDAINED BY THE COUNTY COUNCIL OF UNION COUNTY, SOUTH CAROLINA, AS FOLLOWS:

Section 1. Findings and Determinations. The County Council (the "County Council") of Union County, South Carolina (the "County") hereby finds and determines:

(a) The Santuc Fire District (the "Fire District") is a special purpose district established pursuant to the provisions of Act No. 1305 of the Acts and Joint Resolutions of the General Assembly of the State of South Carolina, Regular Session of 1968, as amended by subsequent acts of the General Assembly ("Act No. 1305") and the favorable results of a referendum held at the same time at the General Election of 1968 by the Union County Commissioners of Election pursuant to Act No. 1305.

(b) The corporate powers and duties of the Fire District are performed by the Board of Fire Control (the "Board") and as such the Board is the governing body of the Fire District.

(c) Act No. 1305 committed to the Fire District the power to buy such fire-fighting equipment as the Board deems necessary for the purpose of controlling fires within the money allocated or made available to the Board for such purposes; to select the sites or places within the area where the fire-fighting equipment shall be kept; and to construct, if necessary, buildings to house such equipment.

(d) Article X, Section 14 of the Constitution of the State of South Carolina, 1895, as amended (the "Constitution"), provides that political subdivisions (including special purpose districts) of the State shall have the power to incur bonded indebtedness in such manner and upon such terms and conditions as the General Assembly shall prescribe by general law.

(e) Article X, Section 14, Subsection (6) of the Constitution provides that if general obligation debt is authorized by a majority vote of the qualified electors of the political subdivision voting in a referendum authorized by law, there shall be no conditions or restrictions limiting the incurring of such indebtedness except as provided therein.

(f) Section 6-11-820 of the Code of Laws of South Carolina 1976, as amended (the "S.C. Code") provides that the county councils of all counties wherein special purpose districts exist shall be empowered to authorize the commission of such special purpose district to issue bonds whose proceeds

shall be used in furtherance of any power of the special purpose district under the procedures described in Sections 6-11-810 *et. seq.* of the S.C. Code.

(g) The County Council of Union County constitutes a “county board” and the Fire District constitutes a “special purpose district”, as such quoted words are defined in the aforesaid provisions of the Enabling Act.

(h) The Board proposes to undertake the design, acquisition, construction and equipping of the following projects: (a) improvement and renovation of existing space with the District’s fire station to include commercial/industrial grade washer and dryer equipment for cleaning turnout gear; (b) an addition to the existing fire station which will contain, without limitation, a combination kitchen/training area, office space and bathrooms with showers; and (c) additional work and improvements to the District’s fire station as may be necessary, incidental or related to the foregoing. The costs of the Projects and costs of issuance of general obligation bonds (described herein) are estimated to be approximately \$500,000.

(i) The Board on behalf of the Fire District has submitted a petition dated May 7, 2024, to the County Council of Union County requesting that the County Council: (a) authorize the issuance of general obligation bonds of the Fire District; (b) order a public hearing upon the question of the issuance of the Bonds; and (c) order that a special election be held in the Fire District upon the question of the issuance of the Bonds; and authorizing the Board on behalf of the Fire District to issue general obligation bonds in the principal amount of not exceeding \$500,000 pending a favorable result in such special election in the Fire District on the question of the issuance of the Bonds.

(j) It is in the interest of the Fire District for the County Council of Union County to authorize the Board of the Fire District to issue not exceeding \$500,000 of general obligation bonds, pending the favorable results of the above referenced special election.

**Section 2. Referendum Ordered.** Pursuant to the aforesaid provisions of the Constitution and laws of the State, there is hereby ordered a special election to be held in the Fire District on November 5, 2024 (the “Referendum”), at which there shall be submitted to all persons qualified to vote under the Constitution and laws of the State of South Carolina the question set forth in Section 4 hereof.

**Section 3. Voting Precincts and Polling Places.** The voting precincts or any portion thereof within the Fire District for the Referendum shall be those designated by Section 7-7-490 of the S.C. Code. The polling places in each of such precincts shall be designated by the Union County Election Commission (the “Election Commission”).

The polls shall be opened at 7:00 a.m. and closed at 7:00 p.m. on the date of the Referendum and shall be held open during these hours without intermission or adjournment.

**Section 4. Form of Ballot.** The Referendum shall be conducted in accordance with the provisions of the South Carolina Code governing voting machines. Such voting machines shall be delivered to the Election Commission for distribution to the Managers of Election at the several polling places. The Election Commission is requested to cause to be printed a sufficient number of ballots for each voting machine used in the Referendum and a sufficient number of emergency ballots for use in the Referendum.

The form of question on the voting machines to be used in the Referendum and the instructions to voters appearing thereon shall be in the form set forth below. However, the format of the question on the ballot may be changed to accommodate voting machines.

Section 5. Qualification of Voters. Every person offering to vote must be at least eighteen (18) years of age and must be duly registered on the books of registration for Union County as an elector in the precinct in which he or she resides and offers to vote on or before the date on which said books of registration are closed for the Referendum, and must present such documents and/or forms of identification as required by State law.

Any registered elector who has moved his or her place of residence after the date on which said books of registration are closed for the Referendum, but before the date of the Referendum, shall be entitled to vote failsafe, providing they qualify to vote in the Referendum at the voter registration office on election day.

Absentee ballots for the Referendum shall be available at the Union County Voter Registration and Elections Office. The books of registration shall be closed thirty (30) days before the Referendum.

**Section 6. Notice of Referendum.** The Council hereby authorizes the publication of a Notice of Referendum to be published in the *Union County News*, a newspaper of general circulation in Union County, South Carolina, in compliance with Section 7-13-35 of the South Carolina Code. Such notice shall be published, substantially in the form hereinafter set forth not later than 60 days before the date of the Referendum and again not later than two weeks after the first notice. Such Notice of Referendum, substantially in the form hereinafter set forth, shall be published again in the *Union County News* at least once not less than 15 days prior to the occasion set for the holding of the Referendum. The Board further authorizes the publication of such Notice of Referendum in such other newspapers as may be necessary or useful.

NOTICE IS HEREBY GIVEN that a Referendum will be held in the Santuc Fire District (the "Fire District") located in Union County, South Carolina (the "County") on November 5, 2024, for the purpose of submitting to all persons qualified to vote in the Fire District, under the Constitution and laws of the State of South Carolina, the following question:

Shall the Board of Fire Control of Santuc Fire District in Union County, South Carolina (the "Fire District") be authorized to issue and sell, either as a single issue or as several separate issues, general obligation bonds of the Fire District in the aggregate principal amount of not exceeding \$500,000, the proceeds of which shall be applied to defray the costs (including architectural, engineering, legal and related fees) of any or all of the following:

1. design, improvement, renovation and equipping of existing space within the Fire District's fire station to include commercial/industrial grade washer and dryer equipment for cleaning turnout gear;
2. design, construction and equipping of additional improvements adjacent to the Fire District's existing fire station which will contain, without limitation, a combination kitchen/training area, office space and bathrooms with showers;
3. additional work and improvements to, and equipping of, the District's fire station and property as may be necessary, incidental or related to the foregoing; and
4. payment of costs associated with the issuance of the general obligation bonds?

If the voter wishes to vote in favor of the question, select "Yes, In Favor of the Question"; if the voter wishes to vote against the question, select "No, Opposed to the Question."

Such question is being submitted pursuant to Article X, Section 14 of the Constitution of the State of South Carolina, 1895, as amended; Title 6, Chapter 11, Article 5, Code of Laws of South Carolina 1976, as amended; Title 4, Chapter 15, Code of Laws of South Carolina, 1976, as amended; and Ordinance No. \_\_\_\_\_ of the County Council of Union County, South Carolina, enacted on [July 9], 2024. If a majority of the qualified electors of the Fire District voting in the Referendum approve the issuance of not exceeding \$500,000 general obligation bonds (the "Bonds"), the Bonds may be issued by the Fire District either as a single issue or from time to time as several separate issues. The Bonds (exclusive of refunding bonds) shall be issued within five (5) years of the date of the Referendum.

The proceeds of the Bonds will be used to defray the costs (including architectural, engineering, legal and related expenses) of the following: (a) design, improvement, renovation and equipping of existing space within the Fire District's fire station to include commercial/industrial grade washer and dryer equipment for cleaning turnout gear; (b) design and construction of additional improvements adjacent to the Fire District's existing fire station which will contain, without limitation, a combination kitchen/training area, office space and bathrooms with showers; and (c) additional work and improvements to the District's fire station as may be necessary, incidental or related to the foregoing; and to pay the costs of issuance of the Bonds.

The precincts or portions thereof within the Fire District and locations of the several polling places for such Referendum are as follows:

PRECINCT	LOCATION OF POLLING PLACE

The polls shall be opened from 7:00 a.m. until 7:00 p.m. at the polling places designated above and shall be open during these hours without intermission or adjournment. Appropriate voting machines will be provided at the polling places for the casting of ballots on the aforesaid question. Managers of Election will be appointed by the Union County Election Commission. The Managers of Election shall see that each person offering to vote takes the oath that he or she is qualified to vote at this Referendum according to the Constitution of this State and that he or she has not voted previously in this Referendum.

Every person offering to vote (a) must be at least 18 years of age on the date of the Referendum; (b) must reside in the Fire District; (c) must be duly registered on the books of registration for Union County as an elector in the precinct in which he or she resides and offers to vote on or before the date on which the books of registration are closed for the Referendum, such date being October \_\_\_, 2024; and (d) must present such documents and/or forms of identification as required by State law.

The process of examining the return-addressed envelopes containing absentee ballots may begin at 9:00 a.m. on \_\_\_, November \_\_\_, 2024 in the Union County Voter Registration Office, 1246 S. Duncan Bypass, Suite B, Union, South Carolina 29379.

Voters who are blind, who are otherwise physically handicapped, or who are unable to read or write are entitled to assistance in casting their ballot. This assistance may be given by anyone the voter chooses except his or her employer, an agent of his or her employer, or an officer or agent of his or her union. The Managers of Election must be notified if assistance is needed. Voters who are unable to enter their polling place due to physical handicap or age may vote in the vehicle in which they drove or were driven to the polls. When notified, the Manager will help voters effectuate this curbside voting provision. Registered voters may be eligible to vote by absentee ballot. Persons wishing more information concerning absentee balloting should contact the Union County Voter Registration Office at 864.429.1616.

The Election Commission is authorized to insert the location of any omitted polling places or change any of the locations of polling places for the Referendum as deemed necessary or advisable. Appropriate changes are authorized to be made in the Notice of Referendum.

Section 7. Election Commission. A certified copy of this Resolution shall be filed with the Election Commission, and the Election Commission is hereby requested as follows:

- (a) To join in the action of the Council in providing for the Notice of Referendum in substantially the form contained herein;
- (b) To prescribe the form of ballot to be used in the Referendum;
- (c) To arrange for polling places in each precinct, or any part of a precinct within the Fire District;
- (d) To appoint Managers of Election;
- (e) To provide voting machines for the Referendum;
- (f) To conduct the Referendum, receive the returns thereof, canvass such returns, declare the results thereof, and certify such results to the Council and the Fire District; and
- (g) To take other steps and prepare such other means as shall be necessary or required by law in order to properly conduct the Referendum.

Section 8. Publication of Notice. In accordance with the provisions of Section 6-11-870 of the Enabling Act, there shall be published for three successive weeks in the *Union County News* a notice of the County Council's action. Such notice shall be in substantially the form set forth in Exhibit A hereto.

Section 9. Authorization of Bonds. Pursuant to the aforementioned Constitutional and statutory provisions and subject to the results of the Referendum being a favorable vote on the question of the issuance of the Bonds, the Board, on behalf of the Fire District, is hereby authorized to issue at one time or

from time to time not exceeding \$500,000 general obligation bonds of the Fire District for the purposes set forth 1(h) hereof or, in the discretion of the Fire District, general obligation bond anticipation notes (the "BANS") in a principal amount of not exceeding \$500,000 pursuant to the provisions of Title 11, Chapter 11 of the South Carolina Code (the "BAN Act"). Pending the favorable results of the Referendum, the Bonds and the BANS shall be issued pursuant to a resolution of the Board adopted in conformity with the terms and provisions of the Enabling Act and the BAN Act, respectively.

Section 10. Direction to Levy and Collect. For the payment of the principal and interest of the Bonds as they respectively mature and for the creation of such sinking fund as may be necessary therefor, the full faith, credit and taxing power of the Fire District shall be irrevocably pledged, and there shall be levied annually by the Auditor of Union County and collected by the Treasurer of Union County, in the same manner as county taxes are levied and collected, a tax without limit on all taxable property in the Fire District sufficient to pay the principal and interest of the Bonds as they respectively mature and to create such sinking fund as may be necessary therefor.

Section 11. Council Authorization. The Board is authorized to do all things necessary or convenient in accordance with applicable law to effect the issuance of the Bonds or the BANS at such time as they deem necessary and in the interest of the Fire District.

Section 12. Repeal to the Extent of Conflict. All orders, resolutions, ordinances and parts thereof, procedural or otherwise, in conflict herewith or the proceedings authorizing the issuance of the Bonds are, to the extent of such conflict, hereby repealed and this Ordinance shall take effect and be in full force from and after its passage and approval.

Section 13. Payment of Referendum Costs; Miscellaneous. All costs and expenses associated with the Referendum shall be paid by the Fire District. The Council hereby authorizes the [Chairman of Council, County Supervisor, and Clerk to Council] to take any and all such further actions as shall be deemed necessary or desirable in order to conduct the Referendum.

Section 14. Ordinance to be Codified. This Ordinance shall forthwith be codified in the Code of the County Ordinances in the manner prescribed by law.

Section 15. Ordinance Effective. This Ordinance shall become effective upon its enactment.

Financials to be included in Council packets for the 12-month period ending June 30, 2024 (100.0% of the year).

- Revenues are reasonable when compared to prior year periods.
- Expenditures are 92.4%, which is on target from time-line standpoint. There are certain payments made at the beginning of the fiscal year that cover the full year, such as general insurance and some maintenance fees, which causing the calculated %-age to be higher in the early months of the fiscal year. Expenditures incurred in Period 13 may reduce the gap between percentage of time (100.0%) and the percentage of budget spent (92.4%) by year end.
- Quarterly Grant update reports are up-to date as of June.
- The 2025 budget process is complete.
- Work has begun on FY 2024 audit activities.
